1. Area of Planned Activity

On behalf of BOWL, autonomous vessel Xocean X06-uncrewed will conduct non-intrusive unmanned survey at several asset locations listed in Table 1. Operations are due to commence 14th March 2025 for a duration of circa 07 days on a 24hr basis, subject to weather with an expected finish date of 21st March 2021

The cable survey will take place along the cable route between F06 – G07 (OTM1). Additional seabed surveys will be conducted centred on a 500-metre radius around each of the following assets A05, D08, F09, F13, G13 & J10. (see locations marked on fig. 1)






Operations will take place subject to weather.

Safety precautions: the USV is equipped with the following to make it conspicuous to other marine traffic:

- AIS
- Navigational Lights and Sound Signal
- Active Radar Reflector

A support vessel will be based in Wick Harbour and be available on standby throughout the campaign.

Although the vessel is unmanned, it is crewed 24/7, piloted remotely using 360-degree cameras and other navigational aids. The X06 can be contacted on VHF channel 16.
